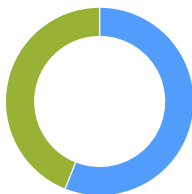

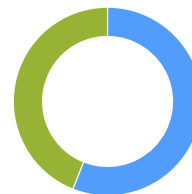
## COMPOSITION BY CURRENCIES
