It is calculated as a total return index in USD and weighted by free-float market capitalization.

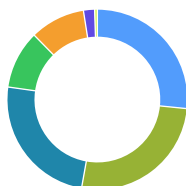

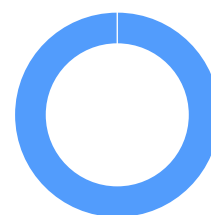
