This document (the "GUIDELINE") is to be used as a guideline with regard to the composition, calculation and maintenance of Each Index (the "INDEX") of the Solactive 10Y Adjusted Yield Index Series. Any amendments to the rules made to the GUIDELINE are approved by the INDEX COMMITTEE specified in Section 5.5. The INDEX is owned, calculated, administered and published by Solactive AG ("SOLACTIVE") assuming the role as administrator (the "INDEX ADMINISTRATOR") under the Regulation (EU) 2016/1011 (the "BENCHMARK REGULATION" or "BMR"). The name "Solactive" is trademarked.

The text uses defined terms which are formatted with "SMALL CAPS". Such Terms shall have the meaning assigned to them as specified in Section 6 (Definitions).

The GUIDELINE and the policies and methodology documents referenced herein contain the underlying principles and rules regarding the structure and operation of the INDEX. #### 1.1. SCOPE OF THE INDEX

#### 1.3. INITIAL LEVEL OF THE INDEX

The initial level of the INDEX on the 01/07/2020, the START DATE, is the level of the respective underlying index. Historical values from the 18/09/2025, the LIVE DATE, will be recorded in accordance with Article 8 of the BMR. Levels of the INDEX published for a period prior to the LIVE DATE have been back-tested.

#### 1.4. PRICES AND CALCULATION FREQUENCY

The Closing Level of the Index is calculated on each Calculation Day based on the Closing Level for the Index Components.

#### 1.5. LICENSING

Licenses to use the INDEX as the underlying value for financial instruments, investment funds and financial contracts may be issued to stock exchanges, banks, financial services providers and investment houses by SOLACTIVE.

### 3. CALCULATION OF THE INDEX

#### 3.1. INDEX FORMULA

The level of the INDEX is calculated according to the following definition:

On the START DATE:

$$Index_t = Y_t$$

On each CALCULATION DAY following the START DATE:

$$Index_{t} = Index_{t-1} + (Y_{t} - Y_{t-1}) + \frac{DCF_{t,t-1} * (repo_{t} - rate_{t})/100}{d_{t,10}/100}$$

$$d_{t,10} = \begin{cases} 1 \\ \frac{1}{Y_{t}/100} \left[1 - \left(1 + \frac{Y_{t}}{100}\right)^{-10}\right], elsewhere \end{cases}$$

Where:

 $Index_t$ : The closing level of the Index as of CALCULATION DAY t.

 $Index_{t-1}$ : The closing level of the Index as of Calculation Day t-1.

 $Y_t$ : The closing level of the Underlying Index as of Calculation Day t.

 $Y_{t-1}$ : The closing level of the Underlying Index as of CALCULATION DAY t-1.

 $DCF_{t,t-1}$ : The Day Count Fraction between CALCULATION DAY t and t-1 in ACT360.

 $repo_t$ : The closing level of the Repo Fund Rate as of Calculation Day t.

 $rate_t$ : The closing level of the Euro Short-Term Rate as of Calculation Day t.

 $d_{t,10}$ : The duration scaling factor as of CALCULATION DAY t.

#### 3.2. ACCURACY

The level of the INDEX will be rounded to 3 decimal places.



#### 3.3. RECALCULATION

SOLACTIVE makes the greatest possible efforts to accurately calculate and maintain its indices. However, errors in the determination process may occur from time to time for variety reasons (internal or external) and therefore, cannot be completely ruled out. Solactive endeavors to correct all errors that have been identified within a reasonable period of time. # 4. MISCELLANEOUS

#### 4.1. METHODOLOGY REVIEW

The methodology of the INDEX is subject to regular review, at least annually. In case a need of a change of the methodology has been identified within such review (e.g. if the underlying market or economic reality has changed since the launch of the INDEX, i.e. if the present methodology is based on obsolete assumptions and factors and no longer reflects the reality as accurately, reliably and appropriately as before), such change will be made in accordance with the Solactive Methodology Policy\_which is incorporated by reference and available on the SOLACTIVE website: https://www.solactive.com/documents/methodology-policy/.

Such change in the methodology will be announced on the SOLACTIVE website under the Section "Announcement", which is available at https://www.solactive.com/news/announcements/. The date of the last amendment of this INDEX is contained in this GUIDELINE.

#### 4.2. CHANGES IN CALCULATION METHOD

The application by the INDEX ADMINISTRATOR of the method described in this document is final and binding. The INDEX ADMINISTRATOR shall apply the method described above for the composition and calculation of the INDEX. However, it cannot be excluded that the market environment, supervisory, legal and financial or tax reasons may require changes to be made to this method. The INDEX ADMINISTRATOR may also make changes to the terms and conditions of the INDEX and the method applied to calculate the INDEX that it deems to be necessary and desirable in order to prevent obvious or demonstrable error or to remedy, correct or supplement incorrect terms and conditions. The INDEX ADMINISTRATOR is not obliged to provide information on any such modifications or changes. Despite the modifications and changes, the INDEX ADMINISTRATOR will take the appropriate steps to ensure a calculation method is applied that is consistent with the method described above.

#### 4.3. TERMINATION

Solactive makes the greatest possible efforts to ensure the resilience and continued integrity of its indices over time. Where necessary, Solactive follows a clearly defined and transparent procedure to adapt Index methodologies to changing underlying markets (see Section 5.2 "Methodology Review") in order to maintain continued reliability and comparability of the indices. Nevertheless, if no other options are available the orderly cessation of the INDEX may be indicated. This is usually the case when the underlying market or economic reality, which an index is set to measure or to reflect, changes substantially and in a way not foreseeable at the time of inception of the index, the index rules, and particularly the selection criteria, can no longer be applied coherently or the index is no longer used as the underlying value for financial instruments, investment funds and financial contracts.



SOLACTIVE has established and maintains clear guidelines on how to identify situations in which the cessation of an index is unavoidable, how stakeholders are to be informed and consulted and the procedures to be followed for a termination or the transition to an alternative index. #### 4.4. INDEX COMMITTEE

An index committee composed of staff from Solactive and its subsidiaries (the "INDEX COMMITTEE") is responsible for decisions regarding any amendments to the rules of the INDEX. Any such amendment, which may result in an amendment of the GUIDELINE, must be submitted to the INDEX COMMITTEE for prior approval and will be made in compliance with the Methodology Policy, which is available on the Solactive website: <a href="https://www.solactive.com/documents/methodology-policy/">https://www.solactive.com/documents/methodology-policy/</a>.



# 5. DEFINITIONS

"BENCHMARK REGULATION" shall have the meaning as defined in Section "Introduction".

"BMR" shall have the meaning as defined in Section "Introduction".

"CALCULATION DAY" is every weekday from Monday to Friday except the following set of days: Target2 holiday calendar.

"CLOSING LEVEL" in respect of an INDEX COMPONENT is a security's final regular-hours published level.

"DATA PROVIDER" is the CME Group.

"GUIDELINE" shall have the meaning as defined in Section "Introduction".

"INDEX" shall have the meaning as defined in Section "Introduction".

"INDEX ADMINISTRATOR" shall have the meaning as defined in Section "Introduction".

"INDEX COMPONENT" is each security reflected in the INDEX.

"LIVE DATE" shall have the meaning as defined in Section 1.3.

"INDEX COMMITTEE" shall have the meaning as defined in Section 5.5.

"SOLACTIVE" shall have the meaning as defined in Section "Introduction".

"START DATE" shall have the meaning as defined in Section 1.3.
