Introduction

This document is to be used as a guideline with regard to the composition, calculation and management of the Index. Any changes made to the guideline are initiated by the Committee specified in section 1.6. The Index is calculated and published by Solactive AG. The name "Solactive" is copyrighted.

1 Index specifications

The Solactive Global Green and Social Bond Investment Grade TR SEK Hedged Index (the "Index") is an Index of Solactive AG and is calculated and distributed by Solactive AG.

The index tracks the performance of Solactive Global Green and Social Bond Investment Grade TR Index and hedges the currency exposure to Swedish Krona on a monthly basis via FX forward contracts.

The Index is published in Swedish Krona [SEK].

1.1 Short name and ISIN

The Index is distributed under ISIN DE000SLA6PY8; the WKN is SLA6PY. The Index is published in Reuters under the code <. SOLGGSS > and in Bloomberg under the code < SOLGGSS Index>.

1.2 Initial value

The Index is based on 100 at the close of trading on the start date, 10th of September 2018.

1.3 Distribution

The Index is published via the price marketing services of Boerse Stuttgart AG and is distributed to all affiliated vendors. Each vendor decides on an individual basis as to whether he will distribute/display the Index via his information systems.

1.4 Prices and calculation frequency

The price of the Index is calculated on each Trading Day based on the prices on the respective Exchanges on which the Index Components are listed. The most recent prices of all Index Components are used. Prices of Index Components not listed in the Index Currency are translated using spot foreign exchange rates quoted by Reuters. Should there be no current price available on Reuters, the most recent price or the Trading Price on Reuters for the preceding Trading Day is used in the calculation.

The Index is calculated every Trading Day from 9:00am to 4:50pm, EST. In the event that data cannot be provided to Reuters or to the pricing services of Boerse Stuttgart AG the Index cannot be distributed.

Any incorrect calculation is adjusted on a retrospective basis.

1.5 Weighting

The index is always fully invested in Swedish Krona.

1.6 Decision-making bodies

A Committee composed of staff from Solactive AG is responsible for decisions regarding the composition of the Index as well as any amendments to the rules (in this document referred to as the "Committee" or the "Index Committee"). The future composition of the Index is determined by the Committee on the Selection Days according to the procedure outlined in 2.1 of this document. The Committee shall also decide about the future composition of the Index. if any Extraordinary Events should occur and the implementation of any necessary adjustments.

Members of the Committee can recommend changes to the guideline and submit them to the Committee for approval.

1.7 Publication

All specifications and information relevant for calculating the Index are made available on the http://www.solactive.de web page and sub-pages.

1.8 Historical data

Historical data is available from the index start date on 14th of September 2018.

1.9 Licensing

Licences to use the Index as the underlying value for derivative instruments are issued to stock exchanges, banks, financial services providers and investment houses by Solactive AG.

2 Composition of the Index

2.1 Selection of the Index Components

The initial composition of the Index as well as any ongoing adjustment is based on the calculation formula outlined in section 3.

2.2 Ordinary adjustment

The composition of the Index is adjusted monthly on the Adjustment Day.

The first adjustment will be made in September 2018 based on the Prices of the Index Components on the Adjustment Day and the Trading Day immediately preceding the Adjustment Day.

3 Calculation of the Index

3.1 Index formula

The Index Value on a Trading Day at the relevant time is calculated in accordance with the following formula:

$$HI_{t} = HI_{RT} \cdot \left(1 + \left(\frac{UI_{t}}{UI_{RT}} - 1\right) + HIM_{t}\right)$$

with:

HI, = Hedged Index on Trading Day t

 HI_{RT} = Hedged Index on the Adjustment Day RT immediately preceding Trading Day t

 UI_t = Underlying Index on Trading Day t

 UI_{RT} = Underlying Index on the Adjustment Day RT immediately preceding Trading Day t

 HIM_{t} = Hedge Impact on Trading Day t, calculated according to the following formula:

$$HIM_{t} = AF_{RT} \cdot \sum_{i=1}^{n} W_{i,ST} \cdot S_{i,ST}^{m} \cdot \left(\frac{1}{F_{i,RT}^{m}} - \frac{1}{IF_{i,t}^{m}}\right)$$

with:

 AF_{RT} = Adjustment Factor on Trading Day t, calculated according to the following formula:

$$AF_{RT} = \frac{HI_{RT-1}}{HI_{PT}}$$

with:

= number of different currencies in the unhedged Index (without considering the currency in which the index is calculated)

 $W_{i,ST}$ = weight of currency i on selection date ST

 $S_{i,ST}^{m}$ = Mid Spot of currency i on day t

 $F_{i,pT}^{m}$ = Mid Forward of currency i on rebalancing date RT

 $IF_{i,t}^{m}$ = interpolated Forward on day t which is calculated as follows:

$$IF_{i,t}^{m} = S_{t}^{m} + (F_{i,t}^{m} - S_{i,t}^{m}) \cdot \frac{D - d}{D}$$

with:

 $S_{i,t}^{m}$ = currency i mid spot rate on Trading Day t

 $F_{i,t}^{m}$ = currency i 1 month forward mid rate on Trading Day t

D = number of calendar days between the last and the next Adjustment Day

d = number of calendar days between the last Adjustment Day and Trading Day t

3.2 Accuracy

The value of the Index will be rounded to 2 decimal places.

Foreign exchange rates will be rounded to six decimal places.

3.3 Calculation of the Index in the event of a Market Disruption Event

The Index is not calculated in the event of a Market Disruption Event. If the Market Disruption Event continues over a period of eight Trading Days, then the Committee will determine the necessary action (including but not limited to taking into account the market conditions prevailing at this point in time, the last quoted Prices for each of the Index Components as well as any other conditions that it deems relevant for calculating the Index value) such that the affected securities resulting from the Market Disruption Event are no longer causing such disruption to occur.

4. Definitions

"Index Component" is each FX component currently included in the Index.

A "Trading Day" is in relation to the Index or an Index Component a Trading Day on the Exchange (or a day that would have been such a day if a market disruption had not occurred), excluding days on which trading may be ceased prior to the normal Exchange closing time. The Index Calculator is ultimately responsible as to whether a certain day is a Trading Day with regard to the Index or an Index Component or in any other connection relating to this document

The "Index Calculator" is Solactive AG or any other appropriately appointed successor in this function.

The "Index Currency" is SEK.

The "Underlying Index" is the Solactive Global Green and Social Bond Investment Grade TR Index.

"Adjustment Day" is the last business Day of each month.

A "Market Disruption Event" occurs if

- 1. the underlying index is not published on a Trading Day
- 2. the respective FX rates are not published on a Trading Day

5.2 Calculation of the Index - change in calculation method

The application by the Index Calculator of the method described in this document is final and binding. The Index Calculator shall apply the method described above for the composition and calculation of the Index. However it cannot be excluded that the market environment, supervisory, legal, financial or tax reasons may require changes to be made to this method. The Index Calculator may also make changes to the terms and conditions of the Index and the method applied to calculate the Index, which he deems to be necessary and desirable in order to prevent obvious or demonstrable error or to remedy, correct or supplement incorrect terms and conditions. The Index Calculator is not obliged to provide information on any such modifications or changes. Despite the modifications and changes the Index Calculator will take the appropriate steps to ensure a calculation method is applied that is consistent with the method described above.
