DÉCLARATION DE CERTIFICATION 3^{ème} TRIMESTRE 2020

Aux utilisateurs de l'Indice,
Au fournisseur de l'Indice Solactive AG:

Forum ETHIBEL asbl a été chargé par **Solactive AG** d'effectuer un contrôle indépendant et une certification de l'indice **Ethical Europe Equity** (SOLEEE Index) portant sur le respect des aspects non financiers de son cahier des charges ainsi que la diligence raisonnable du processus de composition de l'Indice.

Objectif de l'Indice

Sélection univers de composants. L'Indice Ethical Europe Equity est composé d'actions des entreprises appartenant au Registre Ethibel® Excellence Europe, ou dérivé de l'univers de recherche ESG de **Vigeo Eiris**®.

Critères ESG. Dans les deux cas, les composants bénéficient d'un score ESG (Environnement, Social, Gouvernance) global (i) égal ou supérieur à 40/100 et (ii) supérieure à la moyenne du secteur, à la date de publication.

Critères éthiques. Les composants qui n'appartiennent pas au Registre Ethibel: (i) ont pas de participations significatives dans des activités liées à l'armement, aux jeux d'argent, au tabac et aux activités nucléaires et (ii) ne sont pas impliqués dans des violations des normes relatives à l'environnement, au travail ou aux droits de l'homme.

Modalités opérationnelles. **Solactive** et **Vigeo Eiris** se sont entendus sur un scénario de livraison mensuelle de l'univers éligible et de mise à jour trimestrielle de la composition de l'Indice. A cette occasion, l'éventuelle implication des sociétés concernées dans les activités contestables ou dans des violations liées aux critères éthiques est examinée. Les composants qui ne respectent plus les critères sont exclus de l'indice. **Solactive** publie chaque mise à jour de l'Indice, après vérification et certification de **Forum ETHIBEL**.

Portée du certificat

Rôle de Forum ETHIBEL. **Forum ETHIBEL** agit seulement en tant qu'auditeur et organisme certificateur. Le label Ethibel n'est pas impliqué dans la mission.

Sens et portée. Un certificat ou une déclaration de certification est une preuve écrite, indiquant qu'un produit est conforme aux règles ou normes de qualité auto-imposées par le client.

Mission. Un certificat de **Forum ETHIBEL** fournit la garantie qu'un produit ou instrument financier est conforme aux critères extra-financiers comme indiqués dans le prospectus, dans le cahier des charges ou dans les brochures commerciales.

Vérification et révision trimestrielle

Forum ETHIBEL a exécuté son examen conformément aux dispositions de l'accord.

Cette déclaration de certification est basée sur la composition de l'Indice à la date d'ajustement du 6 juillet 2020 et a vérifié la conformité par rapport aux principes énoncés et procédures concernées. Le lecteur est renvoyé à la description détaillée du niveau d'implication et les seuils d'exclusion en annexe.

Tous les éléments de preuve fournis par **Vigeo Eiris** sur les processus de contrôle et de surveillance concernés et les systèmes de gestion internes relatifs à l'exactitude et la qualité ont été vérifiés. Le score ESG de cette entreprise est égal à sa moyenne sectorielle alors que la réglementation impose un score supérieur à la moyenne sectorielle.

The **Ethical Europe Equity Index** will not include stocks of companies:

1. Having a major involvement in the following activities:
 - A. Armament,
 - B. Gambling,
 - C. Tobacco,
 - D. Nuclear.
2. Or not complying with:
 - E. The fundamental ILO convention,
 - F. The fundamental conventions of the UN about human rights.
3. Or having a major involvement in:
 - G. Environmental controversies, allegations or convictions.

A more detailed description of the level of involvement and the exclusion thresholds (based on turnover) are the following:

A. ARMAMENT

Sub-category	Description	Major Involvement
Controversial weapons	Involvement in the development, production, maintenance, use, distribution, storage, transportation or trade of controversial weapons: anti-personnel landmines, cluster munitions, biological, nuclear, chemical, blinding laser, incendiary, and undetectable fragments weapons. E. NON-RESPECT OF ILO CONVENTIONS

F. NON-RESPECT OF CONVENTIONS ON HUMAN RIGHTS

Companies must comply with the International Bill of Human Rights. This IBHR consists of the Universal Declaration of Human Rights, the International Covenant on Economic, Social and Cultural Rights, and the International Covenant on Civil and Political Rights and its two Optional Protocols. There are 9 core international human rights treaties. Each of these has established a committee of experts to monitor implementation of the treaty provisions by its States parties. Some of the treaties are supplemented by optional protocols dealing with specific concerns.

G. MAJOR INVOLVEMENT IN ENVIRONMENTAL CONTROVERSIES, ALLEGATIONS, CONVICTIONS

Companies which are the subject of serious environmental controversies or accusations or convictions are excluded. Elements that affect the qualification 'serious' are: the scope of the impact; the frequency of accidents; transparency; corrective measures and compensations; cooperation with the authorities, local communities and the victims; adjustments on the level of environmental management systems.
