### CONTENT OF THE MARKET CONSULTATION

Solactive AG has decided to conduct a Market Consultation regarding US Presidential "Executive Order on Addressing the Threat from Securities Investments that Finance Communist Chinese Military Companies"; issued on November 12, 2020 (the "**Order**"). The Order will prohibit the purchase of publicly traded securities of certain Chinese companies from January 11, 2021.

### RATIONALE FOR MARKET CONSULTATION

The ORDER directly effects several instruments that are currently members of Solactive indices. We invite our stakeholders, index users and interested third parties to provide feedback on the treatment of Solactive indices because of this ORDER.

- Please provide your opinion on the effect of this order on your investment processes.
- Would you foresee that any change to index composition is required or could the introduction of new "US friendly" indices be desirable addition?
- We are interested to ensure that products related to Solactive indices remain investible, and replicable while maintaining our offering of a broad investible universe to a global client base and reducing unnecessary/undesirable turnover of constituents.
- While the ORDER is directed towards US investors, Solactive AG would be interested to understand the impact on non-US investors, is it likely they will also take a similar investment approach.
