Solactive has implemented a detailed New Index Approval Process (NINA) to ensure the integrity of its benchmarks and to minimize the need for any adjustment of the index methodology. As such, Solactive will only review the benchmark's definition and methodology on an ad hoc basis and not on a periodic basis, such as the "at least annually" period proposed in the BMR.		
Article 5(3)(e) of the BMR: The oversight function shall operate with integrity and shall have the following responsibilities, which shall be adjusted by the administrator based on the complexity, use and vulnerability of the benchmark: (e) overseeing any third party involved in the provision of the benchmark, including calculation or dissemination agents.	Due to the fact that the members of the oversight committee are from different business units, it is Solactive's opinion that the oversight of third parties involved in the provision of the benchmark would be conducted much more efficiently by the Compliance department together with the Operations Team.
