# Content of the Market Consultation

Solactive AG has decided to conduct a Market Consultation with regard to changing the Index Methodology of the following Index (the 'Index'):

### Rationale for the Market Consultation

Solactive suggests the following changes to align with standard market practices and guarantee the diversification of the index. Solactive suggests to raise the rebalance frequency to semi-annual, and to raise the winsorization thresholds to 20%-80%. The changes will allow to capture better momentums and will reduce the overweight due to outliers in growth factors.
