Content of the Market Consultation

Solactive AG has decided to conduct a Market Consultation with regard to changing the Index Methodology of the following Indices (the 'Indices'):

Rationale for the Market Consultation

The rebalancing frequency was recently updated to a quarterly schedule, aligned with GBS logic. Additionally, the methodology currently includes a reweighting on the last business day of August. However, this reweighting originates from the previous version of the methodology, when the index was rebalanced only once per year.

Given the shift to quarterly rebalancing, Solactive suggests to remove the August reweighting, as it has become redundant under the new approach.

Proposed Change to the Index Guideline

The following Methodology change is proposed in the following point of the Index Guideline:

Section 6: Definitions

Old:

"REWEIGHTING DAY" is the last BUSINESS DAY in August.

New:

There is no "REWEIGHTING DAY"
