Solactive has observed that the underlying constituents' exchanges have no trading holidays. To align with the underlying constituents, Solactive has determined update the calculation day, as defined in the guideline, to consider the following

Proposed Changes to the Index Guideline

The following Methodology changes will be implemented in the following points of the Index Guideline (ordered in accordance with the numbering of the affected sections):

From:

"CALCULATION DAY" is any day which the New York Stock Exchange (XNYS) is open for general business.

To:

"CALCULATION DAY" is any day which does not fall on December 24th, 25th, 31st of each year.
