

MARKET CONSULTATION CHANGING OF FX FIXING



Overview of the FX Fixing Changing

The current implementation of FX hedging for the Adjusted Return indices (AR indices) (attached to Appendix I) uses WM London 4PM fixing. A London 4PM fixing was used in the FX hedging implementation to accommodate the global basket of currencies. The current affected indices are USD denominated only.

Proposed Change to the FX Fixing

Solactive has decided to conduct a Market Consultation regarding a proposed change to the FX fixing methodology. The details of the change are as follows:

- Following a review of the current FX hedging implementation, Solactive intends to change the FX fixing from WM London 4PM to WM New York 4PM fixing. The adjustment is expected to provide better alignment with USD-denominated instruments.
- The change will apply on a forward-looking basis only. Historical performance will remain unchanged.
- The updated fixing (WM New York 4PM) will be reflected in the index guidelines.
