#### **COMPLIANCE STATEMENT**

This document represents the Compliance Statement pursuant to Article 26(3) of Regulation (EU) 2016/1011 (the "**Benchmark Regulation**" or "**BMR**") of Solactive AG, an administrator of non-significant benchmarks. As such, Solactive will only review the benchmark's definition and methodology on an ad hoc basis and not on a periodic basis, such as the "at least annually" period proposed in the BMR. |
