	> Exclusion of companies deriving sales from the production of nuclear o coal energy.

Companies are categorized as "Prime" if they achieve or exceed the sector-specific performance requirements defined by ISS bases on the ESG risk exposure and impact of their respective business mode and value chain (absolute best-in-class approach). Prime companies ran among the sustainability leaders in their respective industry.
List of social factors considered	> Exclusion of companies that exhibit severe or very severe controversie according to the criteria of the UN Global Compact.
	> Exclusion of companies developing, producing or distributing controver sial weapons.
