	> Exclusion of companies significantly involved in the sector of coal (generating revenues >10% in this sector)
List of social factors considered	> Exclusion of companies with verified ongoing failure to Principles of the UN Global Compact
	> Exclusion of companies significantly involved in the sector of tobacco (generating revenues >10% in this sector)
	> Exclusion of companies significantly involved in the sector of pornography (generating revenues >10% in this sector)
	> Exclusion of companies significantly involved in the sector of gambling (generating revenues >10% in this sector)
	> Exclusion of companies significantly involved in the sector of alcohol (generating revenues >10% in this sector)
	> Exclusion of companies significantly involved in the sector of military equipment (generating revenues >10% in this sector)
