The FWPL comprises companies which are (1) involved in the manufacture of controversial weapons (2) persistent violators of the UN Global Compact and/or (3) pure coal mining companies. It is reconstituted by LGIM on a semi-annual basis in March and September.> Weighting the securities by incorporating the L&G ESG Score as well as committing to a carbon reduction trajectory.
