List of environmental factors considered	<ul style="list-style-type: none">> Exclusion of companies which exhibit highly unethical behavior, particularly in the context of abuse of the environment.> Exclusion of companies using thermal coal to generate electricity that do not demonstrate sufficient commitment to transition to renewable generation.
List of social factors considered	<ul style="list-style-type: none">> Companies which exhibit highly unethical behavior, particularly in the context of human rights abuses.> Exclusion of companies generating revenues from the production of tobacco or where tobacco is the primary industry.> Exclusion of companies involved in the manufacture and production of controversial weapons (including chemical, biological and nuclear weapons, depleted uranium munitions, cluster munitions, and anti-personnel mines).> Exclusion of companies involved in the hunting of whales and the processing of whale meat.> Exclusion of companies using nuclear reactors to generate electricity that do not demonstrate sufficient commitment to transition to renewable generation.
List of governance factors considered	<ul style="list-style-type: none">> Exclusion of companies which exhibit highly unethical behavior, particularly in the context of endemic illegal activities.> Exclusion of companies producing and supplying defense equipment with insufficient control against bribery and corruption, including improperly supplying such equipment to sanctioned countries.> Exclusion of companies providing gambling services that do not mitigate the social impact of gambling addiction by implementing a suitable responsible gaming policy.> Exclusion of companies producing or distributing palm oil that do not demonstrate sufficient commitment to preventing deforestation through observ-



ing RSP0 and source tracing standards.

Data and Standards used

Data Input	The data used to construct the index is sourced externally from Kiwi Investment Management.
Verification and quality of data	The provider of ESG-related data input is selected by the Administrator based on an assessment of its existing processes in order to ensure the reliability and representativeness of the ESG-related data.
