The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises. > Exclusion of companies generating revenues (in proportion to their total revenues) >5% from coal mining & power generation > Weights of constituents that are classified as \ > by ISS' Carbon Risk Rating are doubled, \ > weight's are halved.

The core normative framework consists of the Principles of the UN Global Compact, the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles for Business and Human Rights. > Exclusion of companies with verified ongoing involvement in the area of controversial weapons (including chemical, biological and nuclear weapons (both under and outside the Treaty on the Non-Proliferation of Nuclear Weapons), depleted uranium munitions, cluster munitions, and anti-personnel mines). > Exclusion of companies generating revenues (in proportion to their total revenues) >5% overall in the sector of military equipment. > Exclusion of companies generating revenues (in proportion to their total revenues) >5% in the sector of pornography. > Exclusion of companies generating revenues (in proportion to their total revenues) >5% from production sector of tobacco. > Exclusion of companies generating revenues (in proportion to their total revenues) >5% overall in the sector of gambling.
