	> Exclusion of companies generating revenues (in proportion to their total revenues) >25% from services in the sector of nuclear supporting products >25% from production or >25% from distribution or >25% from exploration of Nuclear products.
List of social factors considered	Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Prin- ciples of the UN Global Compact, the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles for Business and Human Rights.
	Exclusion of companies with verified ongoing involvement in the area of controversial weapons (including chemical, biological and nuclear weapons (both under and outside the Treaty on the Non-Proliferation of Nuclear Weapons), depleted uranium munitions, cluster munitions, and anti-personn mines).
	> Exclusion of companies generating revenues (in proportion to their total revenues) >10% from services or >10% from production or >10% from dis-

tribution in the sector of military equipment.



	> Exclusion of companies generating revenues (in proportion to their total revenues) >10% from services or >10% from distribution in the sector of tobacco.
