<b>List of environmental factors considered</b>	<ul style="list-style-type: none"><li>&gt; Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises.</li><li>&gt; Exclusion of companies generating revenues (in proportion to their total revenues) &gt;10% from exploration mining or reining of thermal coal, or basing &gt;=30% of their operations on thermal coal or producing &gt;20 million tons of thermal coal p.a. and are actively expanding.</li></ul>
<b>List of social factors considered</b>	<ul style="list-style-type: none"><li>&gt; Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Principles of the UN Global Compact, the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles for Business and Human Rights.</li><li>&gt; Exclusion of companies with verified ongoing involvement in the production, development, or maintenance of controversial weapons (including chemical, biological and nuclear weapons, depleted uranium munitions, cluster munitions, anti-personnel mines, and any other weapon that violate humanitarian principles through normal use), or producing or developing key and dedicated components for controversial weapons, or involved in the production and/or services tailor made for the defense industry or the military. Additionally, companies holding &gt;=20% stake in a company that is involved in controversial weapons or companies currently &gt;=50% owned by a company that is involved in controversial weapons are excluded.</li><li>&gt; Exclusion of companies generating revenues (in proportion to their total revenues)&gt;5% from production or &gt;5% from distribution of arms (both public and private).</li><li>&gt; Exclusion of companies generating revenues (in proportion to their total revenues) &gt;5% from manufacturing of tobacco or &gt;5% from distribution and/or sale of tobacco and/or tobacco products.</li></ul>
