- > Exclusion of companies generating revenues > 0% from manufacturing of military weapons or components
- > Exclusion of companies generating revenues >5% from the operation or manufacturing of specialized equipment used for gambling
- > Exclusion of companies generating revenues > 0% from the production, retail or supply of tobacco related products/services
- > Companies in the bottom 20% in terms of managed ESG risk as measured by the ESG risk score are removed from the index starting universe.
