It is reconstituted by LGIM on a semi-annual basis in March and September.</li><li>&gt; Weighting the securities by incorporating the L&amp;G ESG Score as well as committing to a carbon reduction trajectory.</li></ul>
<b>List of social factors considered</b>	<ul style="list-style-type: none"><li>&gt; Exclusion of companies included in the Future World Protection List (FWPL). The FWPL comprises companies which are (1) involved in the manufacture of controversial weapons (2) persistent violators of the UN Global Compact and/or (3) pure coal mining companies. It is reconstituted by LGIM on a semi-annual basis in March and September.</li><li>&gt; Exclusion of companies with revenues (in proportion to total revenues) &gt; 5% from assault weapons</li><li>&gt; Exclusion of companies with revenues (in proportion to total revenues) &gt; 10% from military weapon system manufacturing</li><li>&gt; Exclusion of companies with revenues (in proportion to total revenues) &gt; 10% from the production or retail of tobacco products and related services</li><li>&gt; Weighting the securities by incorporating the L&amp;G ESG Score.</li></ul>
<b>List of governance factors considered</b>	<ul style="list-style-type: none"><li>&gt; Exclusion of companies included in the Future World Protection List (FWPL). The FWPL comprises companies which are (1) involved in the manufacture of controversial weapons (2) persistent violators of the UN Global Compact and/or (3) pure coal mining companies. It is reconstituted by LGIM on a semi-annual basis in March and September.</li><li>&gt; Weighting the securities by incorporating the L&amp;G ESG Score.</li></ul>
