List of environmental factors considered	<ul style="list-style-type: none"> > Coal: Exploration, mining, extraction, distribution, or refining of hard coal and lignite (one percent or more of revenue) > Oil: Exploration, extraction, distribution, or refining of oil fuels (10 percent or more of revenue) > Gas: Exploration, extraction, manufacturing, or distribution of gaseous fuels (50 percent or more of revenue) > Electric power: Electricity generation with a GHG intensity of more than 100g CO₂e/kWh (50 percent or more of revenue) > Environmental objectives: Fossil Fuel activities (more than 50 percent of revenue) or activities that significantly obstruct the United Nations Sustainable Development Goals that correspond to the EU's six environmental objectives. > A reduction in emission intensity of 50 percent relative to the emission intensity of the Parent Index. > Seven percent annual decarbonisation, which corresponds to a reduction in emission intensity of seven percent relative to the emission intensity of the ActiveBeta® Paris-Aligned Equity Index one year ago.
List of social factors considered	<ul style="list-style-type: none"> > Controversial weapons: Any involvement with biological weapons, chemical weapons, nuclear weapons, depleted uranium, cluster munitions, or anti-personnel mines > Tobacco: Any involvement in the cultivation or production of tobacco products
List of governance factors considered	<ul style="list-style-type: none"> > Global norms: Violation of the United Nations Global Compact principles or the OECD Guidelines for Multinational Enterprises
