It is reconstituted by LGIM on a semi-annual basis in March and September., Weighting the securities by incorporating the L&G ESG Score as well as committing to a carbon reduction trajectory.

It is reconstituted by LGIM on a semi-annual basis in March and September., Exclusion of companies with revenues (in proportion to total revenues) > 5% from assault weapons, Exclusion of companies with revenues (in proportion to total revenues) > 10% from military weapon system manufacturing, Exclusion of companies with revenues (in proportion to total revenues) > 10% from the production or retail of tobacco products and related services, Weighting the securities by incorporating the L&G ESG Score.
