The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises.> Exclusion of companies generating revenues (in proportion to their total revenues) $\geq 10\%$ from Thermal Coal Extraction, power generation, and supporting products or services, or with the significant corporate ownership $\geq 50\%$ from Thermal Coal Extraction, power generation, and supporting products or services.> Exclusion of companies among the 3% highest carbon intensity (total scope 1, 2 emissions divided by enterprise value including cash) per Sector.
List of social factors considered	<ul style="list-style-type: none">> Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises.> Exclusion of companies with verified ongoing involvement in the area of controversial weapons (defense).> Exclusion of companies among the 3% highest carbon intensity (total scope 1, 2 emissions divided by enterprise value including cash) per Sector.
