	> Exclusion of companies exhibiting ESG controversies
	 Exclusion of companies with an ESG risk score lower than 4 globes (ESG risk score <20)
	Companies are ranked according to their Carbon Intensity (calculated as Scope 1 & 2 Emissions divided by Revenues) within each sector. Securities in the bottom 50% within their sector are also excluded.
List of social factors considered	> Exclusion of companies violating the UN Global Compact
	Exclusion of companies generating revenues (in proportion to their total revenues) >10% from production and distribution of small arms (encom- passing Civilian customers (Assault weapons), Retail/distribution (Assault weapons), Civilian customers (Non-assault weapons), Retail/distribution (Non-assault weapons), Military/law enforcement customers, Key compo- nents).
	Exclusion of companies generating revenues (in proportion to their total revenues) >10% from military contracting weapons or >10% from military contracting weapons-related products and/or services.
	Exclusion of companies generating revenues (in proportion to their total revenues) >5% from production of tobacco or >5% from sale of tobacco.
	> Exclusion of companies involved in the area of controversial weapons.
	> Exclusion of companies exhibiting ESG controversies
