List of environmental factors considered	<ul style="list-style-type: none">> Exclusion of companies violating the UN Global Compact> Exclusion of companies generating revenues (in proportion to their total revenues) >30% from power generation and extraction of thermal coal.> Exclusion of companies exhibiting ESG controversies> Exclusion of companies with an ESG risk score lower than 4 globes (ESG risk score <20)> Companies are ranked according to their Carbon Intensity (calculated as Scope 1 & 2 Emissions divided by Revenues) within each sector. Securities in the bottom 50% within their sector are also excluded.
List of social factors considered	<ul style="list-style-type: none">> Exclusion of companies violating the UN Global Compact> Exclusion of companies generating revenues (in proportion to their total revenues) >10% from production and distribution of small arms (encompassing Civilian customers (Assault weapons), Retail/distribution (Assault weapons), Civilian customers (Non-assault weapons), Retail/distribution (Non-assault weapons), Military/law enforcement customers, Key components).> Exclusion of companies generating revenues (in proportion to their total revenues) >10% from military contracting weapons or >10% from military contracting weapons-related products and/or services.> Exclusion of companies generating revenues (in proportion to their total revenues) >5% from production of tobacco or >5% from sale of tobacco.> Exclusion of companies involved in the area of controversial weapons.> Exclusion of companies exhibiting ESG controversies> Exclusion of companies with an ESG risk score lower than 4 globes (ESG risk score <20)
