List of social factors considered	<ul style="list-style-type: none"> > Exclusion of companies found to be in breach of the UN Global Compact Principles. > Exclusion of companies involved in the manufacturing of tobacco products. > Exclusion of companies based on the AFM guideline to ban manufacturers of cluster munitions. Biological and chemical-based weapons manufacturers and nuclear outside the NPT area as well as Anti-Personal Mines, incendiary weapons, blinding laser weapons, and booby traps.
