	Exclusion of companies involved in the manufacture / production of con- troversial weapons (including cluster munitions, anti-personnel landmines, \na biological and chemical weapons).
	Exclusion of companies involved in production, maintenance / service, dis- tribution or research / development of or in relation to core weapons sys- tem or components. Core Weapons systems or components are tailor- made or essential for lethal use of the weapon.
