List of environmental factors considered	> Exclusion of companies with verified ongoing failure to respect the Principles of the UN Global Compact (at least one principle for a continuous\nperiod of 3 years).
	> Exclusion of companies generating a significant proportion of their revenues from the mining of bituminous / lignite coal (b/l coal) or from the \ndeveloped of mining sites for b/l coal or from the processing of b/l coal.
	> In the weighting process the "L&G ESG Score" is used as a tilting mechanism, i.e. the higher the ESG Score the higher the positive tilt of the weights.
List of social factors considered	> Exclusion of companies with verified ongoing failure to respect the Principles of the UN Global Compact (at least one principle for a continuous\nperiod of 3 years).
	<ul> <li>Exclusion of companies involved in the manufacture / production of con- troversial weapons (including cluster munitions, anti-personnel landmines,\na biological and chemical weapons).</li> </ul>
	Exclusion of companies involved in production, maintenance / service, distribution or research / development of or in relation to core weapons system or components. Core Weapons systems or components are tailormade or essential for lethal use of the weapon.

List of governance factors considered	> In the weighting process the "L&G ESG Score" is used as a tilting mechanism, i.e. the higher the ESG Score the higher the positive tilt of the weights.
