List of environmental factors considered	Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Prin- ciples of the UN Global Compact and the OECD Guidelines for Multina- tional Enterprises.
	> Exclusion of companies generating revenues (in proportion to their total revenues) > 50% from services in the sector of fossil fuels or > 5% from production or > 5% from distribution or > 5% from exploration of fossil fuels.
	> Exclusion of companies that are active in the area unconventional oil and gas (oil sands, shale oil and gas).
	> Exclusion of companies that are active in the area of nuclear power.
	> Exclusion of companies with a Corporate Biodiversity Footprint (CBF) score that is >2. The CBF score is provided by Iceberg Data Lab and measures the impact of a company's business on the degradation of ecosystems from their pristine state. Impact is expressed in "Mean species abundance per km2" (km2 MSA). MSA is adjusted for revenues and converted to a sector-normalized score from 1 (best) to 6 (worst).
