List of environmental factors considered	<ul style="list-style-type: none">> Exclusion of companies with verified ongoing failure to respect the Principles of the UN Global Compact (at least one principle for a continuous period of 3 years).> Exclusion of companies generating a significant proportion of their revenues from the mining of bituminous / lignite coal (b/l coal) or from the development of mining sites for b/l coal or from the processing of b/l coal.> In the weighting process the "L&G ESG Score" is used as a tilting mechanism, i.e. the higher the ESG Score the higher the positive tilt of the weights.
List of social factors considered	<ul style="list-style-type: none">> Exclusion of companies with verified ongoing failure to respect the Principles of the UN Global Compact (at least one principle for a continuous period of 3 years).> Exclusion of companies involved in the manufacture / production of controversial weapons (including cluster munitions, anti-personnel landmines, and biological and chemical weapons).> Exclusion of companies involved in production, maintenance / service, distribution or research / development of or in relation to core weapons system or components. Core Weapons systems or components are tailor-made or essential for lethal use of the weapon.> In the weighting process the "L&G ESG Score" is used as a tilting mechanism, i.e. the higher the ESG Score the higher the positive tilt of the weights.
List of governance factors considered	<ul style="list-style-type: none">> Exclusion of companies with verified ongoing failure to respect the Principles of the UN Global Compact (at least one principle for a continuous period of 3 years).> In the weighting process the "L&G ESG Score" is used as a tilting mechanism, i.e. the higher the ESG Score the higher the positive tilt of the weights.
