	 Exclusion of companies generating revenues (in proportion to their total revenues) >0% from Thermal Coal Mining or >5% from Thermal Coal Power Generation.
	 Exclusion of companies generating revenues (in proportion to their total revenues) >0% from Oil Sands Production.
	 Exclusion of companies generating revenues (in proportion to their total revenues) >0% from Shale Oil and/or Gas Production.
List of social factors considered	Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Prin- ciples of the UN Global Compact, the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles for Business and Human Rights.
	Exclusion of companies with verified ongoing involvement in the area of controversial weapons (including chemical, biological and nuclear weapons (both under and outside the Treaty on the Non-Proliferation of Nuclear Weapons), depleted uranium munitions, cluster munitions, and anti-personne mines).
	Exclusion of companies generating revenues (in proportion to their total revenues) >10% from Tobacco Production.

The core normative framework consists of the Principles of the UN Global Compact, the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles for Business and Human Rights.
