The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises. > Exclusion of companies generating revenues (in proportion to their total revenues) >1% from Coal Extraction, Mining, Distribution, Exploration & Refining. > Exclusion of companies generating revenues (in proportion to their total revenues) >10% from Oil Extraction, Distribution, Exploration & Refining > Exclusion of companies generating revenues (in proportion to their total revenues) >50% from Gas Extraction, Distribution, Exploration & Refining > Exclusion of companies generating revenues (in proportion to their total revenues) >50% from Electric Power generated from Fossil Fuels. > Exclusion of companies with a significant negative contribution to the environmental SDGs (SDGs 12-15).
List of social factors considered	> Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises. > Exclusion of companies generating revenues (in proportion to their total revenues) >0% from Tobacco Production and Manufacturing. > Exclusion of companies with verified ongoing involvement in the area of Controversial weapons (including chemical, biological, cluster munitions, and anti-personnel mines).
List of governance factors considered	> Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multina-
