<b>List of social factors considered</b>	<ul style="list-style-type: none"><li>&gt; Exclusion of companies that do not receive Forum Ethibel certification based on a screening of the companies' compliance with ILO conventions and human rights as well as involvement in environmental controversies.</li><li>&gt; Exclusion of Companies with an ESG score less than 40 (out of 100)</li><li>&gt; Exclusion of Companies with an ESG score less than their sector peers</li><li>&gt; Exclusion of companies involved in controversies in human rights issues.</li><li>&gt; Exclusion of companies with major involvement in the area of weapons.</li><li>&gt; Exclusion of companies generating sales &gt;5% in the area of nuclear activities.</li><li>&gt; Exclusion of companies with major involvement in the area of tobacco.</li><li>&gt; Exclusion of companies with major involvement in the area of gambling.</li></ul>

The data providers have established processes in accordance with accepted and established market standards that ensure the permanent quality and reliability of the ESG-data provided.
