List of social factors considered	Exclusion of companies with more than 10% of revenues derived from pro- duction, distribution or supports of products related to Nuclear Energy.
	 Exclusion of companies with more than 10% revenue exposure to Gam- bling, Adult Entertainment, Alcoholic Beverages and Tobacco Products or Military Equipment.
	 Exclusion of companies with any exposure to Anti-personnel mines, Bio- logical and Chemical Weapons, Cluster Munitions, Depleted Uranium as well as Nuclear Weapons.
	Exclusion of companies with verified infringement of established interna- tional initiatives and guidelines (such as UN Principles and OECD Guide- lines).
	Exclusion of companies which have engaged in the follwowing known un- ethical business practices in the last two years: (a) A legal judgement or an official ruling regarding discrimination against any employees, or (b) Two or more legal cases brought against them regarding discrimination against any employees, or (c) a Legal Judgement or an official ruling re- garding unethical practices in its marketing and advertisement
