## ESG Factors Applied in the Benchmark Methodology

> Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises.
> Exclusion of companies generating revenues (in proportion to their total revenues) >50% from services in the sector of fossil fuels or >5% from production or >5% from distribution or >5% from exploration of fossil fuels.
> Exclusion of companies generating revenues from the production or exploration of oil sands.
Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Prin- ciples of the UN Global Compact, the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles for Business and Human Rights.
Exclusion of companies incorporated in countries identified with high social risk if the respective company's state ownership exceeds 50% or the company exhibits alleged failure to respect established international norm. The core normative framework consists of the Principles of the UN Global Compact, the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles for Business and Human Rights.
Exclusion of companies with verified ongoing involvement in the area of controversial weapons (including chemical, biological and nuclear weapons (both under and outside the Treaty on the Non-Proliferation of Nuclear Weapons), depleted uranium munitions, cluster munitions, and anti-person mines).
> Exclusion of companies generating revenues (in proportion to their total revenues) >50% from services or >5% from production or >5% from distribution in the sector of military equipment.
> Exclusion of companies generating revenues (in proportion to their total revenues) >5% in the sector of pornography.

- > Exclusion of companies generating revenues (in proportion to their total revenues) >50% from services or >5% from distribution in the sector of tobacco.
- > Exclusion of companies generating revenues from the production of tobacco.
- > Exclusion of companies generating revenues (in proportion to their total revenues) >50% from services or >5% from production or >5% from distribution in the sector of gambling.
- > Exclusion of companies generating revenues (in proportion to their total revenues) >50% from services or >5% from production or >5% from distribution in the sector of alcohol.
- > Exclusion of companies generating revenues (in proportion to their total revenues) >50% from services or >5% from production or >5% from distribution in the sector of cannabis.
