List of environmental factors considered	<ul style="list-style-type: none"> > Companies engaged in the international water sector, as provided by Global Water Intelligence, are eligible for inclusion into the index > Exclusion of companies listed on the Future World Protection List (FWPL) produced by Legal & General Investment Management (LGIM). FWPL consists of companies that violate the following environmental criteria: (i) Companies with verified ongoing failure to respect the Principles of the UN Global Compact (at least one principle for a continuous period of 3 years) are excluded; (ii) Companies generating a significant proportion of their revenues from the mining of bituminous/lignite coal (b/l coal) or from the development of mining sites for b/l coal or from the processing of b/l coal are excluded
List of social factors considered	<ul style="list-style-type: none"> > Exclusion of companies listed on the Future World Protection List (FWPL) produced by Legal & General Investment Management (LGIM). FWPL consists of companies that violate the following social criteria: (i) Companies with verified ongoing failure to respect the Principles of the UN Global Compact (at least one principle for a continuous period of 3 years); (ii) Companies involved in the manufacture / production of controversial weapons (including cluster munitions, anti-personnel landmines, and biological and chemical weapons); (iii) Companies involved in production, maintenance / service, distribution or research / development of or in relation to core weapons system or components. Core Weapons systems or components are tailor-made or essential for lethal use of the weapon
