| | > Exclusion of companies involved in the area of thermal coal mining or coal power generation. |
| | > Companies are evaluated based on their carbon intensity. Therefore, the carbon intensity values within each sector are winsorized at a 5% level and then transformed into a Z-score. |
| | Exclusion of companies (current index components) ranking in the top 15% based on their carbon intensity score (Z-score). |
| | Exclusion of companies (no current index components) ranking in the top 35% based on their carbon intensity score (Z-score). |
| List of social factors considered | > Exclusion of companies involved in the area of pornography. |
| | > Exclusion of companies involved in the area of tobacco. |
| | > Exclusion of companies involved in the area of gambling. |
| | > Exclusion of companies involved in the area of alcohol. |
| | > Exclusion of defense contractors. |
| | > Exclusion of weapons manufacturers. |
| | > Exclusion of companies involved in the area of controversial weapons. |
