	Exclusion of companies generating a significant proportion of their rev- enues from the mining of bituminous / lignite coal (b/l coal) or from the development of mining sites for b/l coal or from the processing of b/l coal.

List of social factors considered	Exclusion of companies with verified ongoing failure to respect the Principles of the UN Global Compact (at least one principle for a continuous period of 3 years).
	Exclusion of companies involved in the manufacture / production of con- troversial weapons (including cluster munitions, anti-personnel landmines and biological and chemical weapons).
	Exclusion of companies involved in production, maintenance / service, dis- tribution or research / development of or in relation to core weapons sys- tem or components. Core Weapons systems or components are tailor- made or essential for lethal use of the weapon.
