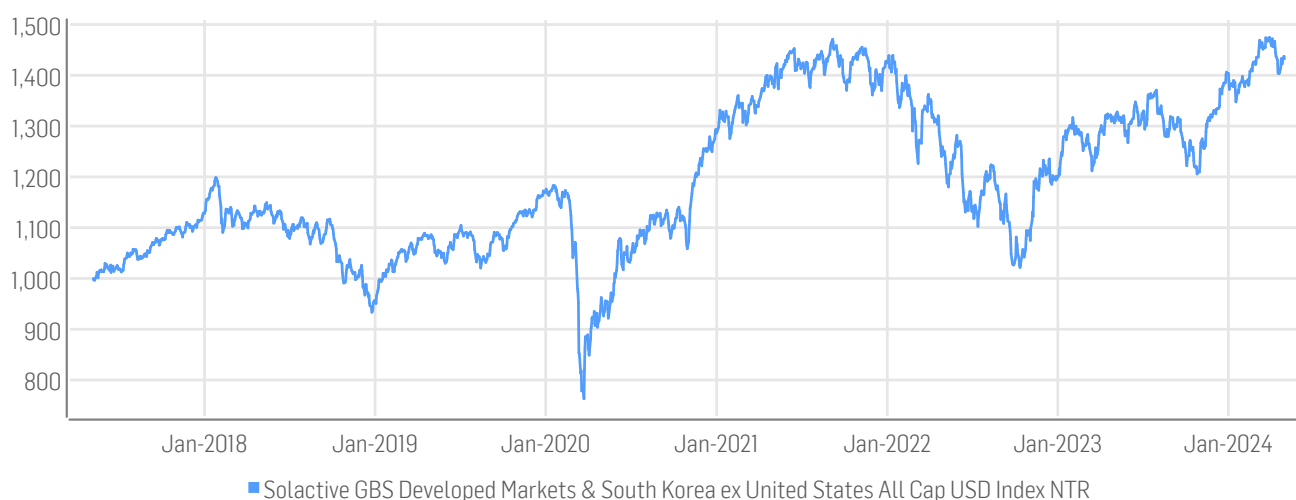


Solactive GBS Developed Markets & South Korea ex United States All Cap USD Index NTR
