Constituents are selected based on full security market capitalization and weighted by free-float market capitalization. The index is calculated as a price return index in USD and reconstituted quarterly.

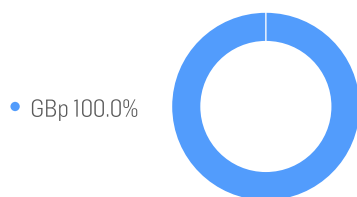

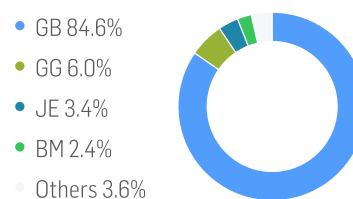
