

# JPMorgan Asset Management Carbon Transition Global Equity Net Total Return Index

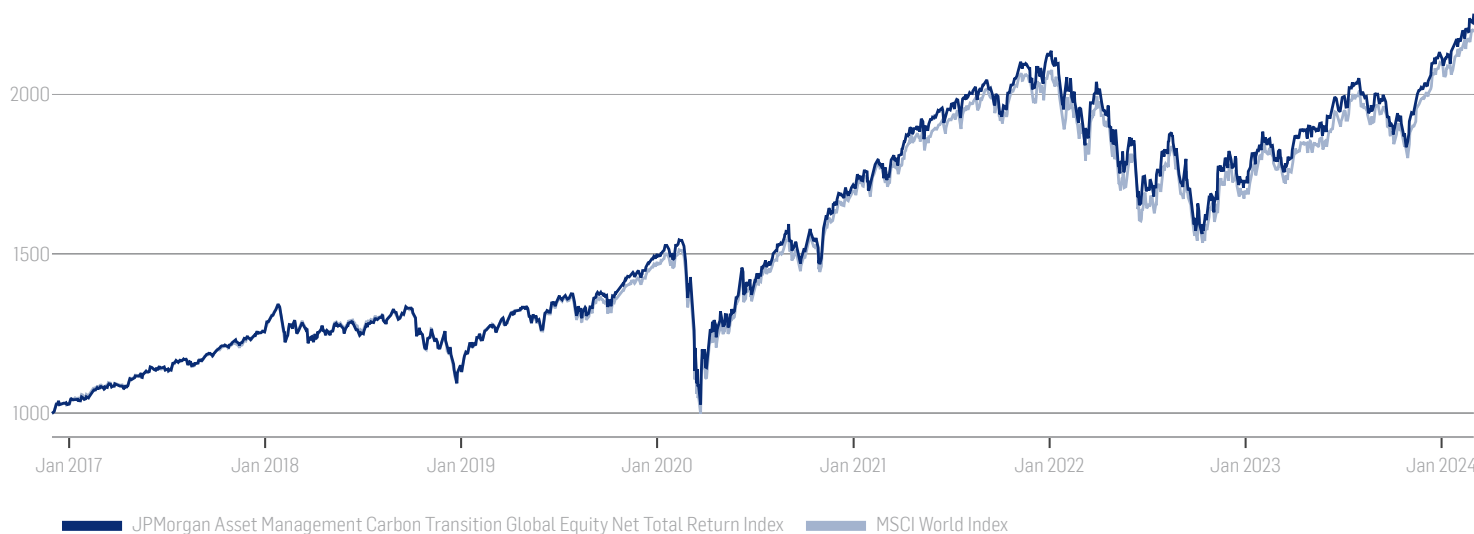
## DESCRIPTION

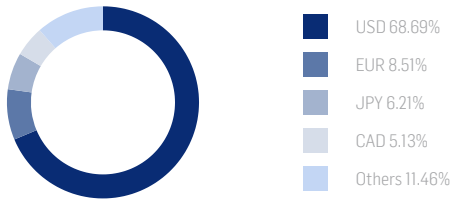

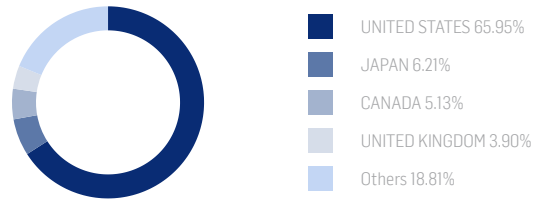

COMPOSITION BY CURRENCIES



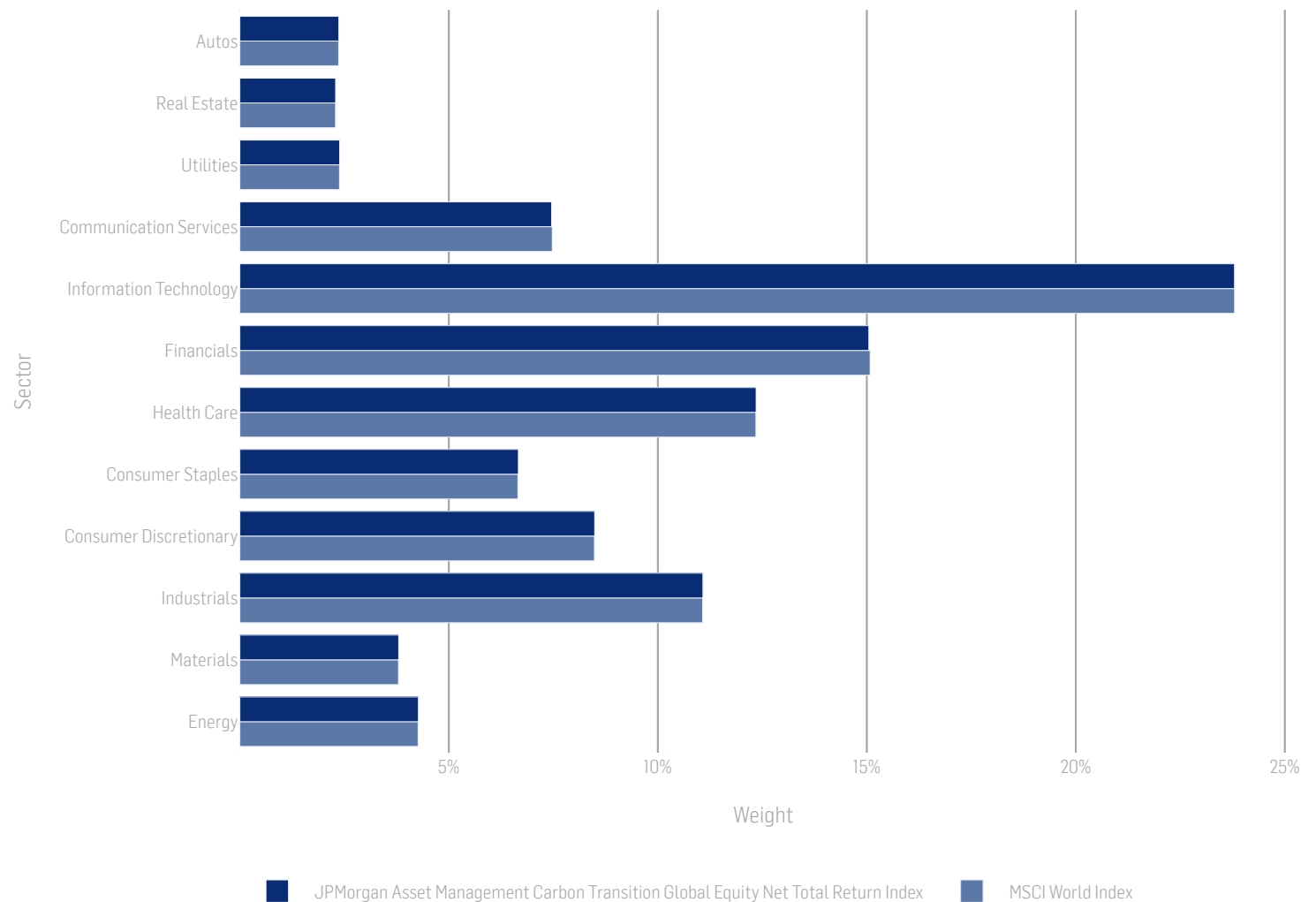
COMPOSITION BY COUNTRIES

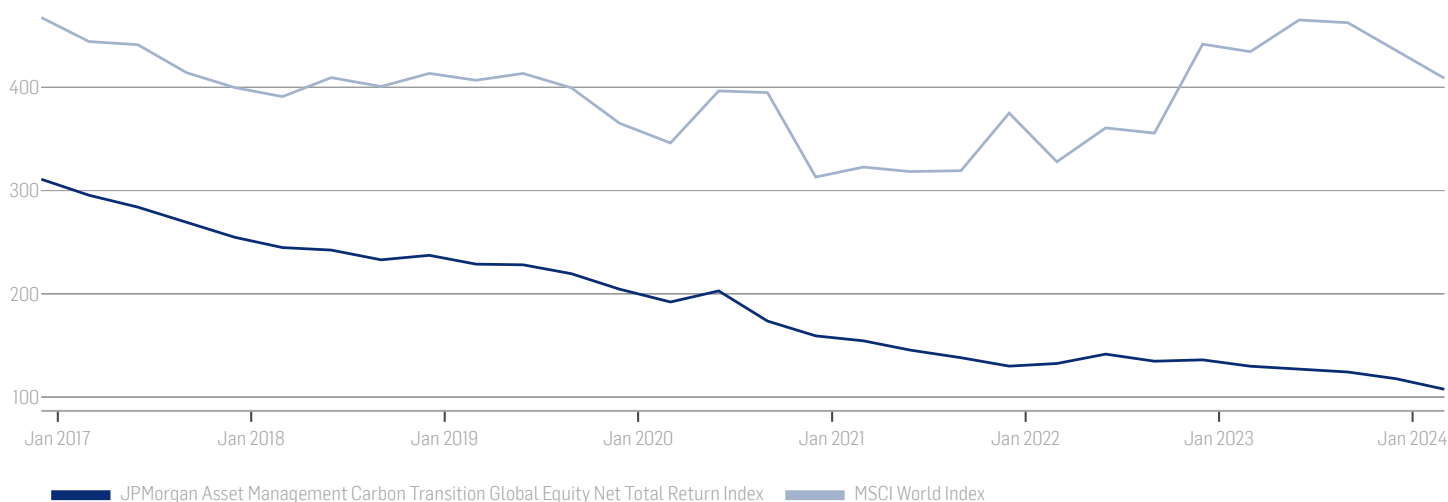

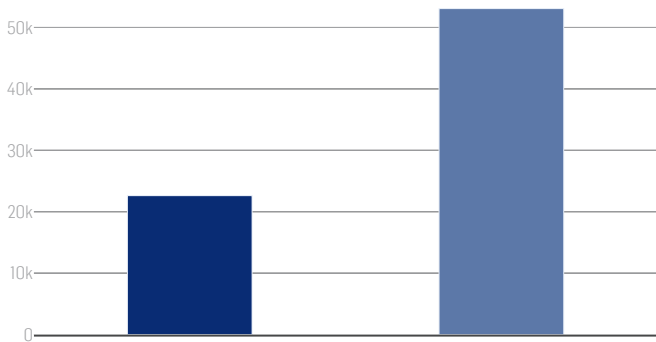

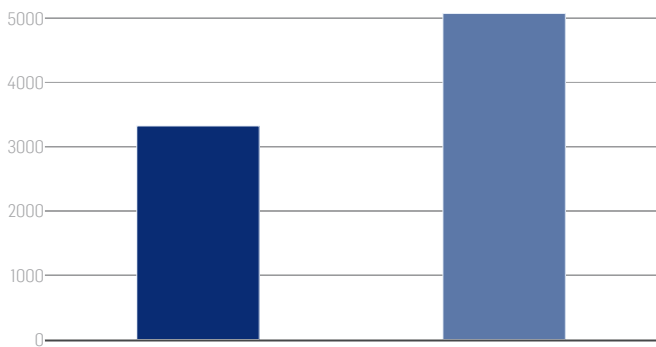

### GHG EMISSIONS SCOPE 1&2

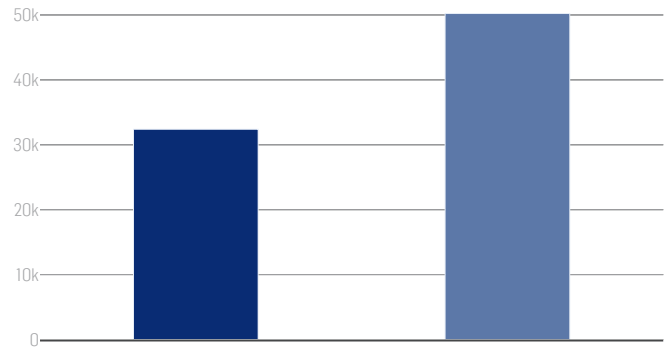

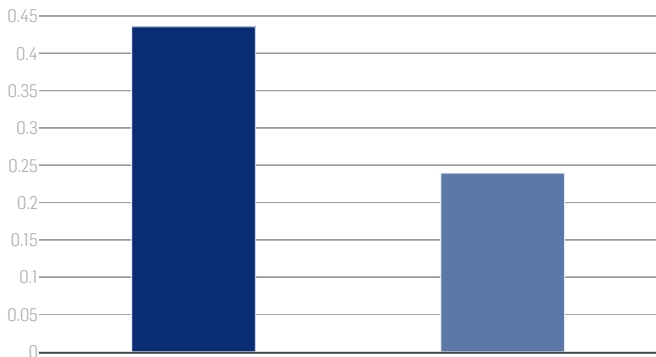
### GHG EMISSIONS SCOPE 3

(Thousand metrics tonnes CO2e)



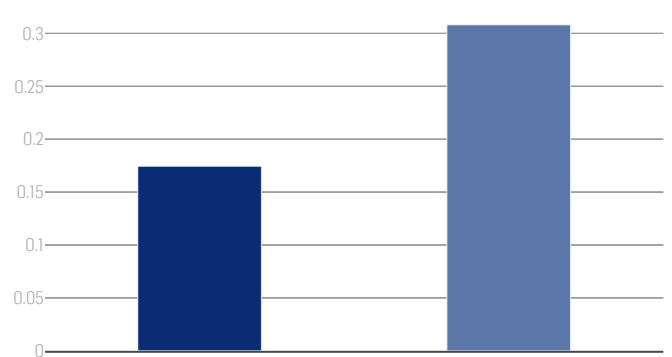
