DESCRIPTION

The Solactive ISS SDG Aligned Developed Markets Index PR is part of the Solactive ISS SDG Aligned Index Series, which aims to track various size and regional segments of the global stock market including only companies with an overall Significant or Limited Positive Impact on the Sustainable Development Goals and no Significant Negative Impact on any of the 17 single Sustainable Development Goals. In addition, companies need to operate in accordance with market standards for responsible business conduct. Those standards are based on established norms such as the United Nations Global Compact. Furthermore, companies involved in controversial weapons are also excluded.

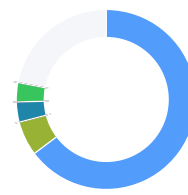
COMPOSITION BY CURRENCIES
