

DESCRIPTION

Representation of Developed Markets securities that are aligned with a 2° C scenario. The securities in the Index exhibit Baseline XDC's less than or equal to their sector-specific Target XDC's and therefore the Index caps climate change to no more than 2° C by 2050. The index is calculated as a TR version in EUR.
