AKTIONÄR Schweiz Index

DESCRIPTION

Rule-based investing with a system. A political dispute between Switzerland and the European Union ensured that companies listed in Switzerland can no longer be traded on EU stock exchanges. With the "AKTIONÄR Schweiz Index", there is again the opportunity to invest with the Confederates. There are 15 companies in the index. The three big players Nestle as well as the pharmaceutical companies Novartis and Roche are set, the remaining twelve companies owe their affiliation to the AKTIONÄR Trend Signal Indicator.

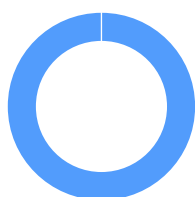

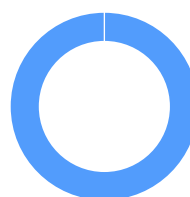
