

DESCRIPTION

The Solactive GPR United States REIT ex Timber and Mortgage Index TR is based on the Solactive GBS United States Investable Universe Index. All index components must be classified as Real Estate Investment Trust, Timber REITs and Mortgage REITs are excluded. The index is weighted by free float market capitalization, calculated as a total return index in USD and reconstituted quarterly.
