

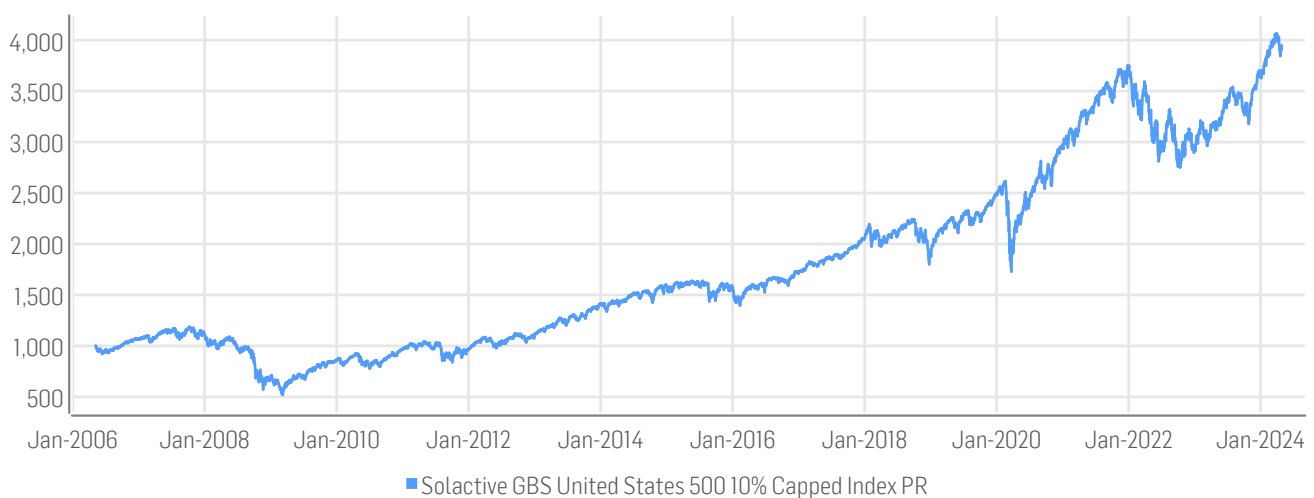

DESCRIPTION

The Solactive GBS United States 500 10% Capped Index PR intends to track the performance of the largest 500 companies from the US stock market and is based on the Solactive Global Benchmark Series. Constituents are selected based on company market capitalization and weighted by free-float market capitalization with weights capped at 10%. The index is calculated as a price return index in USD and reconstituted quarterly.

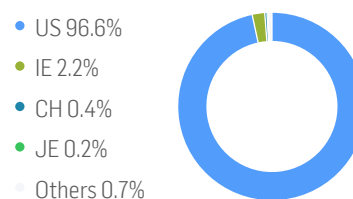
