


# FACTSHEET - AS OF 20-May-2025 Solactive United States 1000 Index NTR

## DESCRIPTION

The Solactive United States 1000 Index NTR intends to track the performance of the largest 1000 companies from the United States stock market. Constituents are selected based on company market capitalization and weighted by free float market capitalization. The index is calculated as a net total return index in USD and reconstituted quarterly.
