

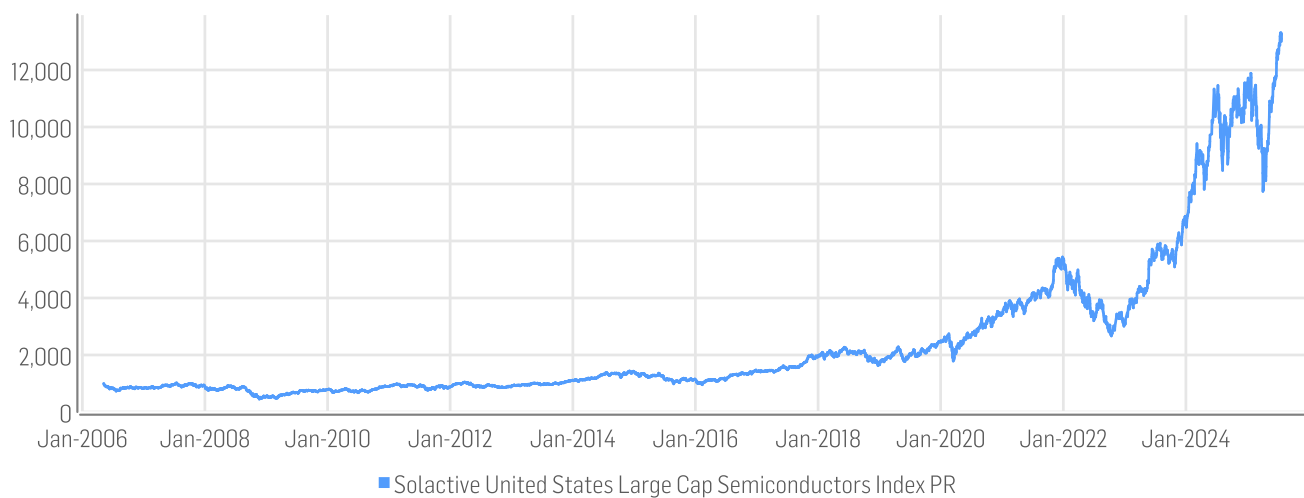

DESCRIPTION

The Solactive United States Large Cap Semiconductors Index PR intends to track the performance of companies involved in the semiconductors industry from the United States stock market. Constituents are weighted on the free-float market capitalization and capped at 30%. The index is calculated as a price return index in USD and reconstituted quarterly.
