


FACTSHEET - AS OF 13-Jun-2025 Solactive United Kingdom 350 EUR Index

DESCRIPTION

The Solactive United Kingdom 350 EUR Index intends to track the performance of the largest 350 companies from the United Kingdom stock market. Constituents are selected based on full security market capitalization and weighted by free-float market capitalization. The index is calculated as a price return index in EUR and reconstituted quarterly.
